Meeting was called to order at 7:00 PM

Public forum regarding agenda items only – Brian Murray Sr. asked if there were any additions to the agenda. Deputy Supervisor Schaal said there may be possibility of one, as there may be action taken after executive session but will not know until later.

<u>Highway Report</u> – (Mike Fuller) – Plow state roads 48 times, salt state roads 42 times, plow town & county roads 33 times, salt town county roads 26 times. Located water leaks for Medina DPW. Read Water pits. Repair and maintain snow plow equipment. Check PPMs. Flushed water #12 to get air out of lines. Cold patched holes. He asked to work with Paul Chatfield to help with Bridge NY Program for replacement of the culvert bridge on Dresser Road and Martin Road.

Mike read the Engineer Report from Chatfield Engineers. Town General Engineering Pre-Demolition Asbestos Survey and testing for the fire department building at 4695 South Gravel Road has been complete. The survey indicated there is a small amount of asbestos containing material that will need to

be removed before demolition. He will contact 3 firms that specialize in asbestos removal to provide a price for removal. He will coordinate a site visit with Mike.

Water Service has been installed and in in service at 5590 Salt Works Rd.

Bridge NY Grant Application-Mike had requested that Paul provide a price for preparing the grant application, State Environmental Review (SEQR) and the Engineering Report in support of replacing the Dresser Road Bridge Culvert. In speaking to the Supervisor regarding this matter, Ed suggested we also apply for the replacement of the Martin Road Bridge Culvert. Paul has prepared proposal for the Town Board's consideration at this evening's board meeting to authorize Chatfield Engineers to assist with the project. He also has prepared letters with supporting the Town Board resolutions relating SEQR and authorization for Mike Fuller to submit the grant application and sign all necessary documents.

<u>Assessor Report</u> – (Trisha Laszewski) – Just a reminder, all renewal exemptions need to be returned to the Assessor by March 1. Change of assessment notices will be sent out next month.

<u>Planning Board Report</u> – (Kirk Myhill) – Working with Mary Herbert regarding banquet facility. Have set up a public hearing for March 6th at 6:45 pm. County sent out a list of spring training sessions for towns to choose what training sessions they would like to take.

<u>Code Enforcement</u> –Issued 1 building permit. Worked 56 hours had 1 snow day where office was closed. Logged 97 miles. Attended Department of State training January 22-24. Earned 24 Department of State Credit hours.

<u>Fire Chief Report-Shelby-Andy Benz gave report of the Shelby Fire Dept.</u> Total calls this year-23. EMS-12, MVA-5, Co2 Detector-2, Auto Alarms-1, Pumping details-1 Mutual Aid to Ridgeway-2. This coming month both engines will have yearly pump and ladder inspections. Firefighter physicals are being scheduled for March. Annual air pack inspection is scheduled for February, have applied for an AFG Grant to replace all of the air packs and air bottles. The Fire Co. will be purchasing 5 complete sets of turnout gear this month to outfit 5 interior firefighters. Upcoming events are Ladies Raffle on February 17, Annual Pancake Breakfast for Maple Sunday. Spring gun raffle is April 21. Annual Mother's Day Chicken BBQ will be on May 13.

<u>Fire Chief Report</u>-East Shelby-Andy Beach gave report of the East Shelby Fire Dept.-Awarded most training hours. Congratulations to Laura Fields on most EMT Hours. Logged 80 calls in 2017.
