<u>Highway Report</u> – Report was given of the past month. Dale reported an MVA on July 15 on Salt Works Rd. resulted in a broken fire hydrant. Estimates were written up, police reports were obtained and it has been billed out to customer insurance. A purchase agreement was signed for the purchase of a Hyundai loader from George & Swede. Worked with Orleans Country Highway on their milling of Town Line Rd. Also assisted the county with paving. Read water meters, there were less re-reads as a result of meters being repaired. Replaced culverts on Bigford and Water Works Rd. in preparation of road repair. Sealed Water Works and Creek Rd finishing up CHIPS funding. Receipts will be submitted to the state for September payment. Removed and repaired the driveway apron at the Job Corp with a federal purchase order to pay for it. Water main repair was completed on Salt Works Rd. Assisted through Shared Services the Village of Medina on the July 27th flooding. Finishing up this round of roadside mowing and have just about finished cleaning up the large pile of tires in our yard, hauling them to Lockport. Daily stacking of E-Waste, mowing fire halls, water vaults and parks have been completed. Throughout the very hot month of July and so far August, the men have done a good job. Councilman Seitz thanked Dale for the good report.

<u>Assessor Report</u>- Trisha reported she finished compiling information for Paul Chatfield for all potential water service in Shelby. Real estate prices are staying steady with sales, prices are above assessment. That's why I hope the town board passes the Town Wide Reassessment resolution.

Planning Board- no report.

<u>Code Enforcement / Zoning Board Report</u> – Dan reported he issued 20 building permits year to date. He is concentrating on violation letters. Been working with Planning Board and Zoning Board of Appeals regarding Tarpon Towers. Public hearing was held. Special Use permit and area variance to Tarpon Tower was approved by Planning Board and Zoning Board of Appeals.
