Meeting called to order at 7:00 PM

Pledge to the flag

Supervisor Smith announced there were no additions or subtractions to the agenda.

<u>Highway Report</u>: (Dale Root) Helped to unload and load Thomas the Tank engine when it was in town. The weed spraying is almost complete. Chip sealed with the help of Royalton, the following roads: Hellert, Fuller and South Countyline. Smith Road was

grader paved with shared services of Barre and Clarendon. It's a busy time of year as they also help neighboring towns attack their projects. Road side mowing continues but not as quickly as he would like but will get a MEO on it as they return from holiday and vacations. Had another water main break on East Shelby Road #10 as he was told. He wanted to say to the board that the men worked well together with the assistance of the village and staff from the Town of Barre. Three and a half hours, start to finish plus the week before there was a water main valve on Rt. 31 leaking from rotten bolts being replaced with stainless steel. Wants to say good job to the men. We continue mowing parks and firehalls and vaults. We had a company come in and check our hydrant meters as mandated by the county health and all three passed. Finally, the stacking and never-ending e-waste.

Assessor's Report: (Trisha Laszewski) On July 1 final assessment roll was filed. NY State tax rebate checks have been issued to property owners. I know one big batch went out and there will be some straggler checks that people should get by the time their school tax bill arrives. If someone feels that they should have received a check and did not, New York State Tax and Finance is the department to contact. She did not have the number but if you call the office, she can supply that number to you. Office traffic has been pretty light this summer and the housing market has not slowed down and the prices are still well above the assessed.

<u>Planning Board Report</u>: (Kirk Myhill) Last month had four of our members attend the state-run training in Albion. He also had one member do the four-hour training online. So, all of the members are up to date on the training. At their meeting Dan came to them and talked about a proposed possibly home business on Harrison Road. No application has been put in yet but he is still working on it. Also, Dan told them a company contacted him about adding on the to the cell tower on Creek Road. It's a cold cave tower that allows up to three antennas. They also reviewed the current site plan for the South Gravel Road wind project and made a referral to the county.

Zoning Board Report: (Dan Wolfe) Issued building permits. It's been slow. A lot of old barns and pools this year but there are four building permits. Wrote three violation letters. One was for a condemned structure on Freeman Road June 21st. He was called by the Orleans County Dispatch to a fire on Freeman Road and we know there was one fatality and he has condemned the structure and issued violation for that. One application was for an area variance. Zoning Board of Appeals met today and passed the variance for the garage in Shelby. Waiting for National Grid to remove the electric lines from 5063 South Gravel Road. Dale had been working with me on it with his contacts. He did not get to it but did talk to Jeff about Ridgeway"s grass and weeds law. Ridgeway has a local law for grass and weeds. The way it works is a letter is sent out and if they don't cut their grass in a reasonable amount of time the town can have it cut and the cost will be applied to the owner's taxes. Dan will retrieve that law from the

Town of Ridgeway and put it in Jeff's mailbox for him to look at. As you know I have talked to you about the house in Millville, sometimes there is absentee landlords. One of the landlords in the particular property is in New York City, there really not much you can do about it so again I will look at the law.
